The purpose of this workshop is to discuss current and evolving rules for the land application of biosolids and chicken manure in the Lake Okeechobee Basin, and to present plans for a new demonstration project to establish scientific basis for such rules and guidelines. The Florida Department of Environmental Protection will describe their current policy for implementing Rule 62-640.500(4), F.A.C., within the Lake Okeechobee Basin. The Florida Department of Agricultural and Consumer Services will discuss future rulemaking concerning guidelines for land application of animal manure. The South Florida Water Management District will introduce a new study to document the phosphorus runoff resulting from application of various types and rates of waste residuals to cattle pastures. Public discussion and comment on these topics are welcome.
